<sup>4</sup> One Night + One Mixed Rec: **Mixed Rec** is Monday afternoon or Friday Mixed Recreational. **One Night only** is Men's, Ladies, Golden Boot and CYO

<sup>5</sup> The **Learn to Curl** applies to new members or a previous member who has not been a member in the last five years. This rate is for eight consecutive weeks of curling based on the curling schedule. If you wish to continue curling after that time, you will be required to pay the full fee of an Unlimited First Year Member, less the amount already paid. This is dependent on space availability in the leagues chosen.

<sup>6</sup> The **Stick League membership** is included in all Group A memberships. . If you do not have a Group A membership, then a Group C membership must include a membership from Group B.

## Fee Payment and Instructions

You may pay for your membership by cash, cheque, e-Transfer or debit.

- If paying by cheque or money order please include your payment, made payable to the Dundas Granite Curling Club, with your Membership Form.
- If paying by e-Transfer make your payment to dundasgranitecurlingclub@cogeco.net and submit your completed form separately.
- If paying by debit you can do so in person at the Curling Club. Please bring your membership form with you.

**PLEASE NOTE THE FOLLOWING:**

- 1) A \$50 administration charge will apply to all cheques returned NSF.
- 2) A \$50 service charge will apply to any withdrawal of membership before the end of November.
- 3) An early payment incentive can be deducted off the total if received by September 30<sup>th</sup>, 2021.  
The payment incentive is not applicable to the Installment Option and Social or Learn to Curl<sup>3</sup> Memberships.
- 4) Returning members will have priority, for available places in the sections they curled in the previous season, until September 30<sup>th</sup>

## Installment Option

It is appreciated if the total payment is made at one time, however you have the option of making 3 equal payments that add up to the Total Fees Due. Payment must be made by cheque and the three cheques must accompany the registration form and be dated September 30<sup>th</sup>, October 31<sup>st</sup>, and November 30<sup>th</sup>.

**Curling Canada, The Ontario Curling Association and The Dundas Granite Curling Club, Limited** (collectively the "Organization") require the disclosure of exposure or illness in order to safeguard the health and safety of all participants and limit the further outbreak of COVID-19. This Declaration of Compliance will be kept safely, and personal information will not be disclosed unless as required by law or with your consent.

An individual (or the individual's parent/guardian, if the individual is younger than the age of majority) who is unable to agree to the terms outlined in this document is not permitted to enter the Organization's facilities or participate in the Organization's activities, programs, or services.

I, the undersigned being the individual named above and the individual's parent/guardian (if the individual is younger than the age of majority), hereby acknowledge and agree to the terms outlined in this document:

- 1) The coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization and COVID-19 is extremely contagious. The Organization has put in place preventative measures to reduce the spread of COVID-19 and requires all individuals (or their parent/guardian, when applicable) to adhere to the compliance standards described in this document.
- 2) The individual has not been diagnosed with COVID-19; **OR** if the individual was diagnosed with COVID-19, the individual was cleared as noncontagious by provincial or local public health authorities.

If the individual travels, or if anyone in the individual's household travels, outside Canada after submitting this Declaration of Compliance, the individual will not attend any of the Organization's facilities, activities, programs, or services until at least 14 days have passed since the date of return~~
- 10) The individual is following recommended guidelines, including but not limited to, practicing physical distancing, trying to maintain separation of six feet from others, adhering to recognized hygiene best practices, and otherwise limiting exposure to COVID-19.
